68/18 PLANNING

- i. 18/01565/HHPA 10 Poolgate, Upper Tysoe Application withdrawn
- ii. 18/01056/FUL Plots 3 And 4, Red Horse Close, Tysoe

This application had been considered by Councillors at the meeting held on 2nd July 2018 when it was agreed unanimously to object to the application. The applicant had subsequently submitted further information and the Council had been offered the opportunity to comment further. Cllr Tongue gave an update. The Parish Council did not understand why there was not a retrospective application for the shed and fencing and an application for a modification of the original landscape conditions.

Cllr Locke proposed objecting, this was seconded by Cllr Collier and Councillors voted unanimously to object.

The Parish Council object to this application for the following reasons:

The garden shed should be retrospective application likewise the garden fence. The fencing of agricultural land as garden land is not conducive to agricultural land. This application does not adhere to discharge of conditions set by Stratford District (SDC) Council to Kendrick Homes regarding hard and soft landscaping.

Concept plan is not acceptable to the Parish Council. A decision can only be made on actual drawn plans to scale. The concept plan should be treated as a modification of the original soft and hard landscaping plan. Therefore, plans should be submitted to SDC which would then come back to the Parish Council for them to decide.

The PC object to change of use from agricultural land to garden please see our previous objections, which include this is becoming more and more of an urban appearance contrary to the rural setting. NPPF, extension of residential curtilage, encroaching into the strategic gap which is now in the second draft Neighbourhood Plan which is out for consultation and there is considerable local opposition which has been registered with SDC.

It is a dangerous precedent to set for future similar applications.

iii. 17/02946/FUL Lindsey House, Tysoe Road, Radway - Permission granted

An email had been received from Stratford District Council Planning setting out new delegated powers for Planning Officers. In future if a Parish Council or Ward member objects to a major or minor planning application it will be referred to the Planning Committee.

A quote had been received from ROSPA to undertake this year's playground inspection. If this is undertaken as part of the cycle in September. Cllr Allen proposed the inspection should take place, this was seconded by Cllr Collier and Councillors agreed unanimously.

Also, a letter was to be sent to the land owner of the footpath between Windmill Way and the field on the Oxhill Road asking them to cut this back as it had become impassable.
